Any person charged with any offense under Title 14 OF L.R.S. must appear in court

All accidents must appear in court

If a fine has a (M) in front of it, treat the charge as a moving violation

Driving records must be checked on all moving violations and an additional \$20.00 is added to the base price of the ticket for every moving violation on the record within a 2 year period

Driving records with more than 3 violations are mandatory court appearances

If the computer is down quote the base price

Any person with a clean driving record for the past two years may attend driving school but they will have to come to court on their court date or call the traffic office for further instructions
